## **ACKNOWLEDGEMENT OF RISK**

In consideration of the services of John and Sena Hauer (also doing business as J S Wranglers LLC, Back Country Mules and Fair Chase Adventures), their offices, agents, employees and all other persons or entities associated with those businesses (hereinafter referred to as JS Wranglers) I agree as follows:

Although JS Wranglers has taken reasonable steps to provide you with appropriate equipment and /or skilled guides so you can enjoy an activity for which you may not be skilled, we wish to remind you that this activity is not without risk. Certain risks cannot be eliminated without destroying the unique character of this activity. The same elements that contribute to the unique character of this activity can be causes of loss of or damage to your equipment, accidental injury or illness or, in extreme cases, permanent trauma or death. We do not want to frighten you or reduce your enthusiasm for this activity, but we think that it is important for you to know in advance what to expect and to be informed of the inherent risks associated with the following activities:

Riding or being near large animals

Riding, hiking and walking on trails and rocky ridges with steep and slippery slopes

Riding in or driving a truck pulling a horse trailer

The following describes some, but not all of those risks:

I understand that I may be exposed to sun, insects, cold water, environmental hazards, biting or stinging animal life and forces of nature. I can be jolted, jarred, bounced, thrown from and shaken about riding equines or traveling in a vehicle through rough terrain. Accidents can occur getting on and off horses and mules and out of vehicles. Exposure to the natural elements could cause sunburn, dehydration, heat exhaustion, heat stroke and heat cramps. I could be hurt by unanticipated movement of rocks, soil or trees. Equipment could break and cause injuries.

I understand the trip may take place in rugged outdoor conditions (including camping) that contain inherent dangers due to weather, backcountry terrain, canyon or river environment, local flora and fauna and distance from hospital facilities. I understand that the planned itinerary may be changed on account of weather conditions and other factors.

I am aware that riding horses and mules and backcountry vehicle travel entails risks of injury or death to any participant. I understand the description of these inherent risks is not complete and that other unknown or unanticipated inherent risks may result in injury or death. I agree to assume and accept full responsibility for the inherent risks identified herein, and those inherent risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate and I elect to participate, in spite of and with full knowledge of inherent risks.

I acknowledge that engaging in this activity may require a degree of skill and knowledge different than other activities and that I have responsibilities as a participant. I acknowledge that the staff of JS Wranglers, LLC has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards and dangers associated with this activity.

I am aware that riding and/or being near horses and mules entail risks of injury or death to myself. I understand that the description of these risks is not complete, and the other unknown or unanticipated risks may result in injury or death. I agree to assume responsibility for the risks identified herein, and for those risks not specifically identified. My participation in this activity is purely voluntary; no one is forcing me to participate, and I elect to participate in spite of the risks.

I possess the following qualifications, which I understand are prerequisites to participation in this activity.

I certify that I and any minor children accompanying me are physically able to participate in this activity or have informed J S Wranglers in writing of disabilities or other conditions that need their special attention or preparation.
